## RULES AND REGULATIONS

1. **NAME:** The Name of the Society shall be **VNR EDUCATIONAL SOCIETY**
2. The Registered office of the Society shall be situated at Markapur with the above address.

3. **Membership:** The Society consists of 7 Members. The governing body may admit members as and when they feel necessary with payment of required admission and membership fee of Rs.1000/- (One Thousand Rupees) each

4. **Functions of the Society:** There shall be two bodies in the functioning of the Society.

1. General body.                      2. Executive Body.

### General Body:

#### Functions of the General body :

- I. A. The Annual General Body meeting of the Society shall be held once in a year i.e. May of every year.  
B. To review the activities of the Society done in past.
- II. To issue instructions to the executive committee and governing bodies of the Institutions owned and managed by the Society for their proper and effective management.
- III. To Setup guidelines and targets for the achievements of the Society.
- IV. To pass the annual budget for the coming year.
- V. To approve the balance sheets of the Society and the institutions under its management.
- VI. To appoint an auditor for scrutinizing the accounts of the associations. If necessary by majority decision.  
(A) To elect a President, Vice-President, Secretary and Correspondent, Joint secretary, Treasurer and members to the Executive Committee from amongst the members once in every two years.  
(B) The General body shall have all powers necessary incidental for carrying out and

- (C) The General Body shall have the power to acquire, purchase or receive properties and to repair or reconstruct properties of the Society. The General Body can delegate these powers to the Executive Committee or to any member therefore.
- (D) An extra ordinary meeting of the General body Convened on the written requisition of at least 7 members thereof with 7 days clear notice to the Secretary to consider any particular subject or subjects.

**Active Body (Governing Body):**

- (A) The management and administration of the body shall vest in the Executive Committee consisting of the President, Vice president, Secretary and Correspondent, Joint secretary, Treasurer and 3 members duly elected by the general body held under clause 4.
- (B) Any vacancy in the executive committee shall be filled up by co-option by the majority of the remaining members of committee from among general body members.
- (1) With regard to the appointments and removals of Teaching and Non-teaching staff in full time or part time the Secretary and Correspondent and President can take the decision after taking the opinion of the subject expert and any one of the Executive Committee members.
- (2) To acquire properties both movable and immovable by gift or by purchase, in the name of the Society represented by President & Secretary.
- (3) To constitute such committees or bodies necessary for the maintenance of governance of the institutions or institutions run by the Society. The Executive Committee shall meet at least once in a month. A meeting of the executive committee shall be held on the written requisition by any three members of the committee with seven days notice to the Secretary and Correspondent.

**President:**

1. President will preside over all the meetings of the Society.
2. He will have casting vote in tie.
3. He will look after the financial matters of the Society in consultation with the Treasurer.
4. Honorary President shall be the permanent member of the general body.

**Vice President:**

5. In the absence of the President, Vice- president shall preside over the meetings of the General Body and performs the functions of the president.

**Secretary:- & Correspondent:-**

1. Shall be the Chief Executive officer of the Society.
2. The secretary shall be in-charge of all the records of the Society and shall be responsible for their proper custody.
3. He/ She shall have the power to award punishment such as suspension, withholding of increment to any of the erring members of the staff and the effected party may appear against the punishment of the Secretary & Correspondent within fifteen days after receipt of the orders of such punishment to the Executive Committee.
4. He/ She shall open and operate the accounts of the Society Along with the President and operate the accounts jointly.
5. He/ She shall prepare budget for the year in consultation with the President and Treasurer.
6. He/ She shall raise funds needed through donations in consultations with the President and other members of the General Body.
7. He/ She shall prepare the agenda for all the meetings of the Society.
8. He/she prepares the minutes of the Society of all the meetings, budget and expenditure statements.

**Joint Secretary:**

In the absence of the Secretary or in case the Secretary delegates his post, the joint Secretary shall exercise the power and perform the duties of the Secretary except withdrawing the amount from the Bank.

**Treasurer:**

1. He has to receive the donations and subscriptions to the Society and issue proper receipt therefore.
2. He shall keep the amount received in the Scheduled Bank or in any other private bank held in the name of Society.
3. He shall prepare and present all accounts to the auditor, general body and executive committee, If necessary.

**Member:**

The members shall co-operate in the realization of the aims and objects of the Society. The members of the general body are elected from the general body.

**Quorum:**

The quorum for the General Body as well as the executive committee is 3/5<sup>th</sup> of the member's.

**Funds:**

The funds of the Society shall be collected by way of subscriptions, contributions and donations etc. The money should be spent for achieving the object of the Society only. They should not be used for the personal needs of the individuals. The funds of the Society shall be kept in any scheduled bank or in any other bank in the Society account in Markapur. The Bank Account shall be operated by the President and Secretary namely **VENNA POLI REDDY** and **SURA SINDHUJA** *Jointly*

**Amendments:**

Amendments to the objects and rules must be made in the general body with 3/5<sup>th</sup> majority. Such amendments must be confirmed in the special general body meeting intended for the purpose only by 3/5<sup>th</sup> of the members present and voting within one month from the first meeting.

**Financial Year:**

The Financial year of the Society shall be from 1st of April to 31<sup>st</sup> March of the Next year.

**Elections:**

The annual meeting of the General Body shall be made in the month of May of every year. The Office bearers shall be elected in every three years. We, the present executive body hereby certify that this is the correct copy of the rules and regulations of, "VNR EDUCATIONAL SOCIETY", Jawahar Nagar Colony, Markapur Mandal, Prakasam District.

### INCOME TAX CLAUSES:-

1. The funds of the institution would be invested as per section 11(5) of the I.T. Act, 1961.
2. The institution / Trust / Society is irrecoverable
3. The accounts would be maintained regularly and would be audited by a chartered accountant as per the Provisions of Income Tax Act.
4. The funds of the trust would be utilized only towards the objects and no portion of it would be distributed in any manner to the trustees or persons defined in section 13(1)(C) of the I T Act, 1961.
5. In the case of winding up / dissolution of the trust / society, the net funds/assets would be transferred to a trust to a trust / society, having similar objects and enjoying exemption U/s 12A and approval U/s 80G.
6. The benefit of the objects of the trust / society would be carried out only with the prior approval of the Commissioner of the Income Tax.
7. Any amendment to the trust deed / MOA/Bye-Laws/Rules & Regulations of the above trust /society would be carried out only with the prior approval of the Commissioner of the Income Tax.
8. The charitable activities should be confined to the territory of India only.

7. To extend free service and financial assistance to the poor and needy people and to provide and utilize human power to the country.







16. To promote study of arts, science and industries and to provide educational facilities.




